1. Cyprus Creek Solar Lease Solicitations

[Mike Federice] Mike presented his memo dated 12/23/15 along with a copy of the letter and term sheet that Cypress Creek Renewables is sending to landowners. Ryan added that he and Staff have received at least ten inquiries from easement owners relative to this topic and expects to receive more. Fred requested the floor and stated that Staff should caution landowners to seek legal advice regarding these leases and any potential flaws that might be detrimental before signing. Duncan pointed out that 20 acres of solar panels on ag land has significantly more impact than the solar panels referred to in our deed for on-site farm use. Ryan has reached out to the Company directly and will keep Committee advised.

VII. STEWARDSHIP UPDATES

1. Hanselman, Ernest A. (PID #6034) – FHP Request

[Mike Federice] Due to warm weather there has been no activity to date on the Ernest A. Hanselman forest harvest. Stewardship staff have been in contact with the Hanselman's forester, Dick McIntosh, regarding the time frame for the logger to move on to the property. Dick McIntosh and Stewardship staff have agreed that although current conditions are very cold, the upcoming rain and warm weather that is forecasted will not be conducive to forest harvest operations with respect to water quality. When conditions are forecasted to remain cold and the ground begins freezing up, Dick will be in contact with Stewardship and Forestry staff to arrange an onsite meeting before the operation begins.

2. Kelly, Randall C. & Lucci M. (PID #6161) – FHP Status [Billy Martin] On December 17th, 2015, WAC Forester Karl VonBerg visited the Randall & Lucci Kelly easement property to inspect the conditions of the skid trails and landings associated with the approved FHP. This FHP does not involve any commercial timber harvesting on the easement property, but skid trails and landings on the easement property

are being used to haul out timber from an adjacent uneased property. Due to the wet conditions of late November and early December, Randall Kelly has decided to shift the harvest focus from the eastern side of the property to the western side, which is higher in elevation and contains less hydrologically sensitive areas. Karl VonBerg did not feel that there were significant threats to water quality resulting from the harvest operations on the eastern end of the property, but did not dispute shifting the harvest to the western end of the property. With regard to the skid trails and landing on the western end of the property, there are a series of 4 water bars approaching the southwest landing on State Route 30 from the north which need to be cleaned out regularly to keep them functioning properly and gravel may need to be applied on the landing to mitigate mud from log truck tires tracking down Route 30. Randall Kelly and Tom Davis, the logger, have been very receptive and communicative with regard to Easement Program guidance. To date, there are no significant water quality issues associated with this harvest.

3. Schoenborn, Johannes Graf von (PID #6147) – FHP Request [Billy Martin] The managing forester for this property has indicated that the loggers have not yet been selected for the project, but the timber sale contract will be going out to bid soon. Stewardship Staff will keep Committee apprised of any updates to this project as they become available.

4. Workload Status - Routine Monitoring, Aerials, Notifications, Reserved Rights, BDRs

Ryan thanked Billy, Mike and Troy for their efforts to complete the 2015 AMVs ahead of schedule. Stewardship staff is ready to start 2016 with a new monitoring schedule, including properties that will be added as we close on new properties.

Before going into Executive Session, Joyce asked for a copy of WAC's appraisal guidelines. Ryan explained that WAC doesn't have appraisal guidelines because valuations are determined by independent third party certified appraisers. All appraisals and subsequent approved offers are consistent with USPAP standards and the appraisers themselves maintain all continuing education requirements. Furthermore, we utilize rotations of our appraisers and approve sub-contracts via RFP. Joyce doesn't feel the appraisals adequately address the loss of future viability. She would like to meet with Council/Committee to discuss the issue.

Ryan responded that Staff can certainly provide further education to any/all EC Members regarding appraisal and valuation techniques, but

"bigger picture" discussions are best reserved amongst key Board members and Committee.
